ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION

This document waives important legal rights. Read it carefully before signing.

As evidence by the signature below, in consideration for my participation in the Show as a volunteer, I agree to the following: I AGREE that “Released Parties” as used herein collectively includes New Vocations Racehorse Adoption Program, Inc., The Jockey Club, the Kentucky Horse Park, and each of the foregoing entities’ respective affiliates and their respective owners, directors, officers, officials, employees, representatives, volunteers, members, insurers, and agents of any kind. I AGREE that I choose to volunteer for the Show. To the extent applicable, I authorize the participation of a junior (under 18 years of age). I am fully aware and acknowledge that horse sports and the Show involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death (“Harm”). I AGREE to indemnify, defend and hold harmless the Show and the Released Parties from and against any claims, demands, suits, liabilities, costs, losses, or expenses (including reasonable attorneys’ fees), of any kind or nature, arising in connection with (i) any Harm to me and any Harm of any nature caused by me to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Show or Released Parties, and (ii) my volunteering at the Show, even if that claim, demand, suit, liability, cost, loss, or expense is due in whole or part to the Released Parties negligence.

I AGREE to expressly assume all risks of Harm to me, including Harm resulting from the negligence of the Show or a Released Party. I acknowledge and agree that the RELEASED PARTIES SHALL HAVE NO RESPONSIBILITY OR LIABILITY FOR ANY INJURY TO THE PERSON OR PROPERTY OF MYSELF (AND/OR THE MINOR FOR WHOM I HAVE EXECUTED THIS AGREEMENT), ANY OWNER, LESSEE, TRAINER, AGENT, RIDER, HANDLER OR ANY OF THEIR RESPECTIVE GUESTS, INVITEES, EMPLOYEES, CONTRACTORS OR AGENTS. IN NO EVENT WILL THE RESPECTIVE PARTIES BE LIABLE TO ME (AND/OR A MINOR FOR WHOM I HAVE EXECUTED THIS AGREEMENT) OR TO ANY THIRD PARTY FOR ANY INDIRECT, CONSEQUENTIAL, SPECIAL, EXEMPLARY, PUNITIVE OR INCIDENTAL DAMAGES, WHETHER IN CONTRACT, TORT, NEGLIGENCE OR OTHERWISE ARISING FROM OR RELATING TO THE SHOW. I ASSUME THE ENTIRE RESPONSIBILITY AND LIABILITY FOR LOSSES, DAMAGES AND CLAIMS ARISING OUT OF PERSONAL INJURY OR PROPERTY DAMAGE CAUSED DIRECTLY OR INDIRECTLY BY ME.
